



PUPPY CONTRACT

\$_____ IS DUE AT THE TIME OF PUPPY PICKUP AND *Here With The Wind (HWTW)* INCLUDES THE FOLLOWING:

- Transfer of ownership of an exceptional HWTW puppy (bred for gentle character, color and confirmation) and rights to limited AKC registration
- Series of dewormings beginning at 2 weeks old, any age-appropriate vaccinations, removal of dewclaws, and microchip
- Health certificate from veterinarian attesting to the good health of your puppy.
- Promise of full refund (purchase price only) for exchange of dog if genetic defects are found (veterinary proof) within 1 year of purchase
- The sound nutrition of parents and puppy that have been fed a high-quality diet
- A keepsake for puppy- a toy/blanket with their mom's scent, and a 20lb bag of puppy food to ensure the smooth dietary transition to your home.

This agreement is legally binding upon signing, and concerns the purchase of a *Here with the Wind* Great Dane puppy, whelped on _____, 20___. Said puppy is a M/F dog and was previously identified by the name, _____.

Buyer/New Owner Obligations at time of purchase and thereafter:

1. _____ puppy will be examined by your regular veterinarian for a confirmational health-check within 5 days of purchase. Veterinarian findings/health check results, shall be provided to breeder at: hwtwgreatdanes@gmail.com, within 10 days of purchase. The return of your puppy for a refund of the full purchase price shall be permitted, in accordance with the professional findings of your veterinarian. Initiation of said return/refund must be in writing and occur within the aforementioned 10 day window. Under no circumstances will we be held responsible for any expense incurred by you during this 10 day period. **Buyer Initials**_____.



2. Your puppy is microchipped with a _____ microchip and registered to *Here With The Wind*. This chip shall be updated and registered with your information, but *Here With The Wind* shall remain registered on the chip as a secondary party for the **length of the dog's life**. 3. Puppies being registered with the limited AKC registration shall have the prefix, "HWTW" attached to their registered name. **Buyer Initials**_____.
4. Your Great Dane puppy is loved by our *Here With The Wind* family*. Upon purchase you assume the responsibility that we would have otherwise provided, and agree to
 - a. provide a comfortable environment
 - b. proper nutrition
 - c. yearly vaccinations, (Parvo every 6 months)
 - d. monthly heartworm, flea and parasite control
 - e. appropriate exercise
 - f. prompt medical attention
 - g. no breeding without written consent from breeder at *Here With The Wind*
 - h. proper grooming, socialization and overall, provide responsible, humane care for the **full length of the dog's life**. **Buyer Initials**_____.

***Please Note: if at any time, for any reason, there is suspicion of maltreatment or abuse of our dogs, we reserve the right to resume ownership of said dog for the length of the dog's life. We will prosecute animal cruelty/abuse to fullest extent of the law.**

If Buyer cannot keep this dog for any reason, we will have the right of first refusal for the full length of the dog's life. Written consent of *Here With The Wind* is mandatory to transfer or sell this dog for the full length of the dog's life. We have a responsibility to keep our dogs out of puppy mills, pet stores, shelters, and rescues. We will not issue a refund due to Buyer's remorse, difficulty housing a dog and/or any other reason Buyer cannot continue ownership, other than the above-referenced veterinary reason occurring within the first 10 days of possession and any genetic defect found with veterinary proof within one year of purchase.

We reserve the right to refuse any dog returned for faulty temperament if seller deems that such temperament was due to Buyer's negligence or abuse. **We do not guarantee the behavior of any dog.** It is further agreed upon that we will be held harmless by the Buyer for any damage(s) awarded,



settlements, or judgments resulting from any damages/injuries sustained and/or caused by said dog as described herein.

This contract shall be deemed legal and binding between *Here With The Wind Great Danes*, and Buyer _____, and is under the jurisdiction of the State of Florida, in the county of **Jefferson. It is further agreed that should any dispute/arbitration arise between *Here With The Wind Great Danes*, and Buyer regarding the dog described herein; that the legal venue shall be Jefferson county in the State of Florida.**

By signing below, you agree that you are of sound mind and understand the entirety of the contract/agreements herein. If there is any clause in this contract that is not upheld by Florida law, both buyer and seller will be bound by the remainder of the contract.
